

United Engine Company – Lansing, Michigan



"United Engine Company, when first initiated, had a rather complicated corporate structure, which makes the company history difficult to untangle. United Engine Company first appeared in January 1911 as the United Manufacturer's Association of Jackson, Michigan. A year later in a 1912 issue of *The Gas Engine*, it was noted that United Manufacturer's Association had relocated from Jackson to Lansing, Michigan. It was further noted that the name had been changed to "United Engine Company". In addition, C. L. Sprinkle,

company president, was prominently noted in every advertisement, further linking the transition of the two company names. In addition, there were other gas engine manufactures, with similar names, operating at the same time including United Factories Co., Cleveland, Ohio; United Engine Manufacturing Co., Hanover, Pennsylvania; and United Manufacturing Co., Detroit, Michigan. Another interesting fact regarding the United Engine Company is that it never built its own engines; rather the company became

a middleman between the manufacturer and the end was widely known, the Associated Manufacturers, Waterloo, Iowa, was the prominent engine builder for United. There may have been other builders as well including such companies a Gibson, Port Washington, Wisconsin. Throughout the life of United Engine Company, engine were made available in sizes ranging from 1 ½, 2 ½, 3 ½, 4 ½, 6, 8, 10, 12, and 14 horsepower, and ranging in price from \$28.00 to \$281.25. In 1917 Associated announced its "lowa Oversize" line of engines, which was soon followed by United's new series of engines as well. The new line of United Engines featured a 15-horsepower engine advertised for sale at \$342. Topping the 1927 line was a double cylinder 25-horsepower engine, identical to that sold by Associated Manufacturers. With the



advent of Rural Electrification Administration extending electricity to the farm, and the general decline of gas engines for farming use during the 1930's, United Engines gradually faded into oblivion. A *Farm Implement News Buyer's Guide* of the 1940's noted that repair parts for the Associated Engines, which were the same as United, were available from WHW Machine and Tool Works of Lansing, Michigan. Even though United Engines were practically identical, even down to the same part numbers, the same publication listed "No Repairs" under the United Engine Company heading.

Ole and Sven's Fishing Trip

One evening Ole and Sven were standing on shore up north on Norway Lake. They were loading a couple large old wooden barrels, full of norther's and walleyes, onto their rusty 1963 Ford pickup, getting ready to head back to the farm. Suddenly a conservation officer came upon the boys, stopped them and inquired about the large quantity of fish being loaded onto their trusty old Ford truck. "Do you have a permit to catch all those fish?" inquired the officer. "No sir, all of these fish are pets", replied Ole. "Your pet fish? How is that?" questioned the officer. Confidently, Ole and Sven assured the officer, "Well, every night we take our pet fish here for an outing in the lake, we let them swim for about a half hour, then whistle and they all come back and jump into the barrels, then we all go home. We do this every evening". Furious, the officer

replied, "Well, that is nothing but a crock of lies!" Ole and Sven assured the officer that it was all true, and then offered to demonstrate. The officer then said, "Well this I got to see!" The boys then proceeded to

release the fish into Norway Lake. After about five minutes of silence, the officer inquired, "Well.....?" Ole and Sven replied, "Well, what.....?" "The fish", insisted the officer, "Where are your pet fish?" Ole and Sven in their usual Norwegian demeanor replied, "What fish?"

The farming committee was asked to say a few words about last year's corn crop on county land. We averaged about 130 bushels/acre on the corn. Naturally, you wonder why we didn't get 200 plus bushels per acre like the "big boys." In June we had lots of rain, and with the big hills, the water all ended up down below on untiled ground so we drowned out about 13 acres. The members put about 1000 bu. ear corn in the crib and the rest went to the Montevideo elevator.

This coming year we will plant soybeans. The seed is ordered from Pioneer and again will be donated by Pioneer, as they have done since we took over the county land. It looks like we'll have to live with low grain prices for a while which means our income from grain will be lower.
