

Any discussions or consideration of organizational dissolution has been terminated. Thank you.

## **HERITAGE HILL - Meeting Date and Time Response from the Board**

There was a discussion at the last board meeting in regards to a few requests from members to go back to monthly membership meetings and moving them back to Tuesday nights. There are a few reasons why meeting dates and times have been changed. Attendance at membership meetings has dwindled since the pandemic and has not come back. Many membership meetings had ten members or less. We tried different nights to see if that would change. It did not.

Several officers and board members live quite a ways away so it's not convenient to drive to Montevideo for meetings twice a month. Others have young children or children who are active in school making weeknights impossible to get to meetings. In the past, all officers and board members lived locally and did not have children living at home.

Also, with decreased membership involvement at Heritage Hill, there just is not enough things going on to have an agenda worth having a meeting over.

We will never find a time and meeting schedule that is ideal for everyone but we are doing the best we can to keep things happening at Heritage Hill.
