

# PRESIDENTIAL STATE OF THE HILL ADDRESS:

Greetings from Heritage Hill. With the month of March upon us, I now feel like winter is winding down, assuming we do not have another late spring like 2014 or 2013. I am optimistic. Spring is soon here, the landscape will soon green and all the joys of another growing season will be upon us.

February 14 and 15 was a good weekend for Heritage Hill at the Great Minnesota Get Together at the Lac qui Parle High School. Another 126 raffle tickets were sold which is relatively equal in comparison to other years. It was fun to see and visit with many friends and neighbors who have been hibernating for the winter. Congratulations to Jerry Berge of Rosen who was the winner of the 1/16<sup>th</sup> scale Cockshutt 70 toy tractor given away after the weekend raffle ticket sales. If you do not know where Rosen, Minnesota is located, then you are long overdue for a Sunday drive, destination northern Lac qui Parle County.

The demolition of the former Len's Supper Club, at the corner of Yellow Medicine County Road 7 and US Highway 212, near Wegdahl, noted the end of another area landmark. The supper club opened for business sometime in the early 1960's and served its last meal sometime in the early 1990's. After its closure, the floods of 1997 and 2001 damaged the building beyond repair. As of late the building's roof was falling in and weed trees were lining its perimeter. The site soon became the property of Yellow Medicine County and demolition was inevitable. Road house establishments, such as Len's, were common along the corridor between Montevideo and Granite Falls. In earlier years prohibition was its catalyst. Many decades prior, and not far from Len's Supper Club, were a couple of establishments then known as Skunk Hollow and the Bronze Boot. Prior to 1934 the pathway between Granite Falls and Montevideo had yet to be enhanced and the location proved to be a great out-of-the-way place for the illicit speakeasy businesses.

US Highway 66, linking Chicago to Los Angles, probably has the distinction of the most historic highway in the United States, included in song, and full of legend, folklore and tradition. Although popular, Highway 66 is not the only highway in the United States with interesting history attached. First identified as a federal highway in 1926, US Highway 212 holds its share of historical data as well. It is interesting to note that there are two federal highways, in close proximity to each other, crossing Minnesota from east to west and with close numerical identifications – US Highways 12 and 212. As always, searching the internet revealed some answers as to how US 212 evolved over the years. US Highway 12 was one of the original national highways spanning from Detroit, Michigan on one end to Aberdeen, Washington on the other end. US Highway 212 actually started as a spur off of US Highway 12. It started in Willmar at the intersection of Litchfield Avenue and what is now Business Highway 71, formerly



the corner of US Highways 12 and 71. It then ran south on present day Business 71, westerly on Kandiyohi County 19, then southwesterly on present day Minnesota Highway 23 to Clara City, then west on present day Minnesota Highway 7, then winding its way through Montevideo to Trailways Café corner, then all the way west terminating in Belle Fourche, South Dakota. In 1934 the US 212 designation was removed from the Willmar to Montevideo segment, and the highway corridor assumed its present day path southeast to Granite Falls, then easterly to Chaska and up to Saint Paul. With prohibition ending in 1933, the speakeasy establishments along the sleepy, river-bottom roadway from Montevideo to Granite Falls needed a new source of revenue. The increased highway traffic which then started in 1934 came just in time as weary travels needed food and rest along the way. Highway 212 has long held the title "Yellowstone Trail" as its westerly terminus is the northeast entrance to Yellowstone National Park.



Interest in the utilization or the Heritage Hill show site continues. As reported earlier plans are in place for the April 24, 25 and 26 Montevideo Xpo sponsored by the Montevideo Area Chamber of Commerce. Recently, the Montevideo Noon Lions have been in contact requesting the use of Heritage Hill to host another circus. More information will be forthcoming as the circus plans further develop. The Heritage Hill Board of Directors is currently looking at ways to enhance the Saturday night entertainment during the annual Threshing Show. Preliminary contacts have been made with a metro based professional garden tractor pulling organization to determine its level of interest in attending the show. On Saturday, February 21, James Roe, Ronald Molde, Orlynn Hegna and I were invited by Vice President Chris Thurk to attend the Minnesotans Go-Pher Cockshutt organization's annual meeting. The event was held at Charlie's Café in Freeport. This summer Heritage Hill will be hosting the organization's regional Cockshutt gathering as well as featuring the Cockshutt tractors. We as honored guests were given the opportunity to

promote Heritage Hill in front of approximately 30 members who attended the annual meeting. Heritage Hill buttons and a cup were presented to the members present.

Finally, I would like to remind all Heritage Hill members that the monthly membership meetings will resume starting with the March 16<sup>th</sup> meeting to be held at the Montevideo Community Center. Hope to see you there.

# NOTES FROM THE SOUTH



# What is it?

The first of these Motor Wheels were developed in 1910 in England and called the Wall Motor Wheel. The Wall Motor Wheel was a one cylinder one horsepower air cooled engine used only on British made bicycles. This is Briggs & Strattons entrance into the small engine world. The first ones we ever saw was in Pioner Park in Zolfo Springs Florida. From then on "enquiring minds want to know." Here is the story.

The A. O. Smith Company bought the manufacturing rights to the Wall Motor Wheel in 1914. A. O. Smith Company then produced the Smith Motor Wheel for use on American made bicycles and a Cyclecar called the Smith Flyer. The Smith Motor Wheel was a single cylinder air cooled one horsepower engine that sold for \$60.00. The Smith Flyer sold for \$135.00 and was equipped with the Smith Motor Wheel. The Smith Motor Wheel could easily be attached or fitted alongside the rear wheel of bicycles started then lowered to the ground to go forward. The same procedure was done with the Smith Flyer. Over 60,000 Smith Motor Wheel were sold for use on bicycles and on the Flyer. In 1920, Briggs & Stratton acquired the patents and manufacturing rights of not only the Smith Motor Wheel but the Smith Flyer Cyclecar. Briggs & Stratton then re-designed the Smith Motor Wheel into a one cylinder air cooled engine with two horsepower. They also redesigned the Smith Flyer into the Briggs and Stratton Flyer. Sales of the Briggs and Stratton Motor Wheel also included use on American bicycles.
