PRESIDENTIAL STATE OF THE HILL ADDRESS:

Who would have thought that we would be looking at multiple inches of snow in the third week of October! Unless it is faded in my memory, this was the heaviest snowfall, before Halloween that I recall. Thankfully it has mostly melted. Fortunately, I had finished field work before the bitter cold arrived. The corn ground tillage was completed during the October 20 snowstorm. The weather forecast predicted 3 to 6 inches but when I finished up chisel plowing there was a solid 8 inches of accumulation. The wheel-slip on the four-wheel drive increase from 6% to 18% by the time I finished. In all my years of farming, that is by far the worst snow event while completing field work.

Heritage Hill held its fall plow day on Saturday, October 31, resulting in a nice turnout of tractors, plows and volunteers. It was tough plowing as the ground was hard and very slick in spots. We all kept after it and after about 5 hours we had everything turned over that needed to be plowed.

The Heritage Hill annual election is now over. Thank you to all who took the time to vote and congratulations to all elected officers and directors, who will now continue to lead the organization. I want to thank all members who agreed to their respective nomination. It takes many people to operate the organization and leaders to steer it in the right direction. His history is not as deep with Heritage Hill as some members, but he is looking forward to digging in, doing what need to be done and get aquainted with the entire membership. Grant has attended many different threshing shows so he has a good understanding on what it takes to make a show a success. Congratulations to Scott Thissen and Chantel Hamann. Scott was re-elected as a director and Chantel will be serving her first term as a director on the board. Thank you to Stephen Coon for serving 5 years. He is looking forward to continuing his involvement at Heritage Hill.

I want to thank you all for allowing me to serve in the Heritage Hill leadership role for the past two years. It is with mixed emotions that I leave the presidency.
